<u>Publication of revised results of 3rd round seat allotment for admission to Medical and Dental Courses</u> as per the orders of the Hon'ble High Court

- 1. The provisional result of the 3rd round seat allotment for admission to UGNEET 2025 Medical and Dental courses was published on the KEA Website on 24-10-2025.
- 2. With regard to the provisional result of the 3rd round seat allotment, the Hon'ble High Court in Writ Petition NO. 31934 / 2025 and related Writ Petitions 32428, 32391, 32510, 32519 has delivered the divergent orders. In view of this the Hon'ble High Court has constituted a three-judge bench and transferred the case to the bench.
- 3. The Hon'ble three-Judge Bench, in its judgment dated 05-12-2025, has quashed the provisional seatallotment list of the 3rd round published by KEA on 24-10-2025 and has given the following directions for allotment of seats based on the options already submitted by the candidates.
 - "[B] The KEA is issued with the following directions:
 - [ii] To firstly undertake the process for allotment of the additional seats [443 seats] for those candidates who are permitted to participate and this process shall be based on the Options as already entered.
 - [iii] To secondly undertake the process for allotment of those additional seats which are not taken in the first stage as mentioned in direction [B][ii].
 - [iv] To next undertake the process for allotment of "the Consequential Seats" [377 seats] and the seats that remain after the process under direction [B][ii] and B[iii]."

The said order has been published on the KEA Website.

- 4. As per the said order, the provisional result of the 3rd round of seat allotment published on 24-10-2025 stands cancelled. In view of the said orders of the Hon'ble High Court and by considering the options already entered by the candidates, the 3rd round seat allotment has been made as detailed below:
 - a) For the 443 seats from nine colleges included in the 3rd round, all the 3rd round candidates are considered for allotment with already entered option.

- b) Due to allotment out of 443 medical seats, 301 MBBS seats gave up by the students who have already selected MBBS seat in first or second round, for these 301 seats also all the candidates were considered for allotment.
- c) The seats that were available at the commencement of the 3rd round (Consequential Seats) and the seats which were cancelled due to various reasons up to 05-12-2025 and the seats remaining after the seat allotment in the above order are considered for allotment in the 3rd round itself as per rules.
- 5. The revised provisional result of the 3rd round medical and dental seat allotment as per the above method will be published on 06-12-2025 (after 3.00 PM) and objections, if any, can be mailed to KEA keauthority-ka@nic.in before 3.00 pm on 07-12-2025.
- 5. The final result of the 3rd round medical and dental seat allotment will be published on 08-12-2025 (after 11.00 AM) and the candidates who may get allotted in the final results should compulsorily report to the concerned college.
- 6. The schedule of further procedure to be taken by the candidates who have been allotted seats after the final result of the 3rd round seat allotment is given below:
