## About AP LAW CET 2026

AP LAW CET (Andhra Pradesh Law Common Entrance Test) is one of India's premier state-level law entrance examinations, conducted by the **Andhra Pradesh State Council of Higher Education (APSCHE)**, Hyderabad. The exam serves as the gateway for admissions to **5-Year Integrated LLB (BA LLB / BBA LLB)** and **3-Year LLB** programmes across all law colleges in Andhra Pradesh. The 2026 edition was held on **May 4, 2026** and results were declared on **May 18, 2026**.

### Key Eligibility Facts:

- General category: Minimum **35% marks (42 out of 120)** to qualify.
- SC / ST categories: **No minimum qualifying marks** required.
- 5-Year LLB: 10+2 pass; 3-Year LLB: Graduation in any discipline.
- There is **no upper age limit** to appear for AP LAW CET.
- Approx. **8,000 seats** for 3-Year LLB and **3,000 seats** for 5-Year LLB across AP.

## AP LAW CET 2026 Counselling Process

The **APSCH** conducts AP LAW CET 2026 counselling through an **online web-counselling** mode at [lawcet-sche.aptonline.in](http://lawcet-sche.aptonline.in). Counselling Phase 1 is tentatively scheduled for **September 2026**. Follow the step-by-step process below:

### 1 Counselling Notification

APSCH releases the official counselling notification through AP newspapers and on the portal [lawcet-sche.aptonline.in](http://lawcet-sche.aptonline.in). The notification includes schedules, counselling centre details, documents required, and fee structure.

### 2 Online Registration & Fee Payment

Qualified candidates must register on the official counselling portal by entering Hall Ticket number, Date of Birth, AP LAW CET score, and personal/educational details. Pay the counselling registration fee online. Download the fee receipt immediately.

### 3 Certificate Verification at Counselling Centres

Visit the designated counselling centre as per your rank and schedule. Carry originals + 2 sets of photocopies of: AP LAW CET Rank Card, 10th/Intermediate/Degree Marksheets, Caste Certificate (if applicable), Income Certificate, Aadhaar Card, and Passport-size photographs. Verification is mandatory to proceed.

**4 Web Option Entry (College Choice Filling)**

After certificate verification, participate in web-option entry either from official help centres or any internet-connected system. Select preferred colleges and courses in order of priority. Choices once submitted follow merit-based allotment — rank and preference both matter.

**5 Seat Allotment (Phase 1)**

APSCHE publishes the seat allotment list on the portal based on merit rank and web options submitted. Download your Seat Allotment Letter from the website. Candidates not allotted in Phase 1 may participate in Phase 2.

**6 Reporting to Allotted College**

Candidates whose names appear in the allotment list must physically report to the allotted college. Pay the admission/tuition fee at the college and complete document verification for final seat confirmation.

**7 Phase 2 Counselling (if applicable)**

If you could not secure a seat in Phase 1, participate in Phase 2 counselling. The process mirrors Phase 1: register, fill options, receive allotment, and report to college. Unfilled seats are redistributed in subsequent rounds.

Passport-size Photographs (6 copies)	For all counselling and admission forms
Counselling Fee Receipt	Downloaded after online fee payment
