**Subject: Online submission of List of Candidates for Class XII Supplementary Examination 2026 reg.**

**Madam/Sir,**

It is informed that the process for submission of Class XII LOC for Supplementary Examination, for session 2025-26 shall start **w.e.f. 30.06.2026 (Tuesday)**. The submission of List of Candidates (LOC) is to be done through the PARIKSHA SANGAM link provided on CBSE Website <https://cbse.gov.in>.

The following category of candidates can apply for appearing in the Supplementary Examinations 2026:-

- Compartment (1st chance) for Candidates appeared for 1<sup>st</sup> time in Class XII (&) their result is Compartment.
- Improvement of Performance (candidates passed after replacement of subject(s) in Main Examinations 2026).
- Improvement of Performance in 01 subject in class XII who passed in Main examinations 2026. **List of permissible subjects (Annexure-4).**

- (D) Compartment (3rd chance) students (who appeared in class XII for 1<sup>st</sup> time in exam-2025) can appear only as Private candidate. (A separate circular for Private candidates has also been issued and is available on CBSE website [www.cbse.gov.in](http://www.cbse.gov.in). Only those students whose name is submitted through the online process shall be allowed to appear for Supplementary Examinations, 2026. The schools will have to use their Affiliation Number as a user ID and the password already available with them for login to the system for submission of LOC. The following important information may be read and understood carefully:-

**1) Please note for compliance -**

- a) Students who have appeared for the board's examinations for session 2025-26 as regular students from CBSE affiliated schools and whose result has been declared as compartment should approach the school from which they have appeared in 2026 main examinations for sponsoring of their name for supplementary examinations.
- b) Similarly, the schools shall also contact their students placed in the Compartment category and inform them about their candidature for the supplementary examinations.
- c) Also, the schools shall inform their candidates if declared pass but wish to improve their performances in 01 subject in Class XII (Only for candidates who passed in the 2026 Main exams) their names may be added.
- d) **Schools should submit LOC for all the students placed in the Compartment category even if they are unable to contact the students. Non-submission of the name of the student will cease the opportunity to appear in the supplementary examinations.**
- e) It will be the responsibility of the schools to submit LOC within the stipulated schedule.
- f) Kindly ensure that schedule be adhered to strictly for submission of LOC to avoid inconvenience to any candidate.




- 2) The schools shall submit the names of the students in the LOC for supplementary examinations-2026 as per the conditions of eligibility given in **annexure-I**.
- 3) It is also informed to the schools that the students who appeared in session **2024-25** in full subjects (i.e, 5/6/7 as per the Scheme of Studies) either as regular students through schools affiliated to the Board or as Private Students, and their result was declared as "COMPARTMENT" and they could also not pass in Compartment-2025 Exams (1st Chance) and 2026 examinations (2<sup>nd</sup> Chance), all such students are eligible to apply only as Private Students for 3<sup>rd</sup> and last chance in Supplementary Examinations-2026,
- (a) Maximum of three chances are available for a student to pass an examination if placed in the compartment category in the main examinations.
- (b) Schools may advise/direct such "Private Students" to apply online directly through CBSE's website, whenever approached. The schedule for submission of LOC/application forms will be the same for both Regular and Private Students.
- 4) In case of any difficulty/queries regarding online submission, the IT Branch of the concerned Regional Offices can be contacted for clarification/assistance. The contact details of the Regional offices are available on the link <https://www.cbse.gov.in/cbsenew/contact-us.html>.
- 5) Consolidated mark sheet will be issued only to the students whose result was declared COMPARTMENT in Board's Examinations-2026 and who will be declared Pass in Supplementary Examinations-2026.
- 6) The Supplementary Examinations-2026 will be conducted based on the Syllabus prescribed for the Board examinations for session 2025-26, which is available on the CBSE website.



- 7) The Improvement of Performance can only be done in one subject already appeared for in the Main examination.
- 8) The LOC may be filled as per the current status of the result of the candidates.
- 9) **The schedule of Supplementary Examinations:-**

Supplementary Examination for class XII will be held on **28 July 2026 (Tuesday)**.

The dates for download of Admit Cards will be informed separately. In case of any discrepancy in the Admit card, schools should contact the concerned Regional Office of the Board immediately.

<b>FOR REGULAR STUDENTS</b>	
<b>ELIGIBILITY CRITERIA FOR SUPPLEMENTARY EXAMINATIONS 2026</b>	
<b>ELIGIBILITY CRITERIA: CLASS XII</b>	
<b>A.</b>	Regular students who appeared in Board's Examinations 2026 through schools affiliated to the Board and declared as COMPARTMENT are eligible to apply only in one subject in which they are placed in the Compartment.
<b>B.</b>	Regular students who appeared in Board's Examinations 2026 through schools affiliated to the Board with 6 subjects and placed in COMPARTMENT in two subjects are eligible to apply in any one of the two subjects in which placed in the Compartment.
<b>C.</b>	Regular students who appeared in 6 subjects in Board's Examinations 2026 and declared PASS but could not clear one subject, can appear in the failed subject under the Improvement of the Performance category only in the subjects whose examinations will be conducted.
<b>D.</b>	Regular students who appeared in the Board's Examinations 2026 and declared PASS can appear in any one subject under the Improvement of the Performance category only in the subjects whose examinations will be conducted.

<b>B.</b>	<p>Before payment of the fee, schools can take the print of LOC in the form of a checklist. Once the fee is paid, the final LOC will be printed, and no correction could be made in the online or offline mode thereafter.</p>
<b>C.</b>	<p>It is the responsibility of the school to ensure that fee is in such a manner that it is updated in Board's account on or before the last date. In case of Bank related transactions or non-updation of Fees on the server, the schools should contact the respective bank through which payment was made.
