Competent Authority of the University has approved inviting OFFLINE APPLICATIONS from candidates WHO HAD SO FAR "NOT REGISTERED" for admission in a particular courses on the basis of any of the applicable merit for a particular programme i.e. respective National Level Test Score, Common Entrance Test Rank, and; the CUET Score.

Not Eligible Candidates for this Round of Offline Counselling

'Registered' in the context of courses where admissions are carried out on the score of National Level Test

Who have filled the application form and deposited Rs.2,500/-

'Registered' in the context of courses where admissions are carried out on the score of Common Entrance Test

Who have filled the application form + appeared in CET + registered on Counselling portal

'Registered' in the context of courses where admissions are carried out on the score of CUET

who have registered on the University portal for CUET 2026.

Eligible Candidates for this Round of Offline Counselling

It is reiterated that only, and only, the candidates who had not registered (by submitting the online application form and paying the application fee of Rs.2500/- in case of B.Tech.(JEE), BA/BBA LLB (UG CLAT), MCA (NIMCET) and MBA (CAT/CMAT) and; for BBA, B.Com, BCA, BA English, BA Eco, BHMCT, MBA and MCA whose names appeared in the CET 2026 merit list but had not registered further on counselling portal) are eligible to apply for this round of counselling and the candidates had not registered themselves for CUET also.

The eligibility criteria and other terms and conditions shall remain as prescribed in the Admission Brochure 2026-2027.

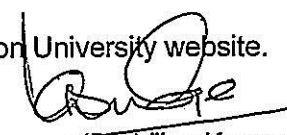
